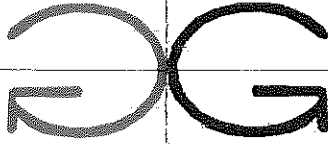

On behalf of TC Systems Inc, Giomare Group is hereby requesting from the City of Lowell, permission to lay, maintain and operate underground conduits, with the cables to be placed therein, under the surface of the following public way:


University Ave, from utility pole #1 at the intersection of University Ave and Riverside Street to Verizon manhole #272 on University Ave, one (1) 4-inch PVC conduit, approximately 186-feet in length.

The conduit will be placed at an approximate depth of 36-inches and in accordance with the requirements of the City's Department of Public Works.

Three (3) sets of a plan entitled "TC Systems Inc. Proposed Conduit Placement Plans University Avenue – Riverside Street and Father Morissette Blvd. – Aiken Street Lowell, MA", dated 10-17-17 are filed herewith. 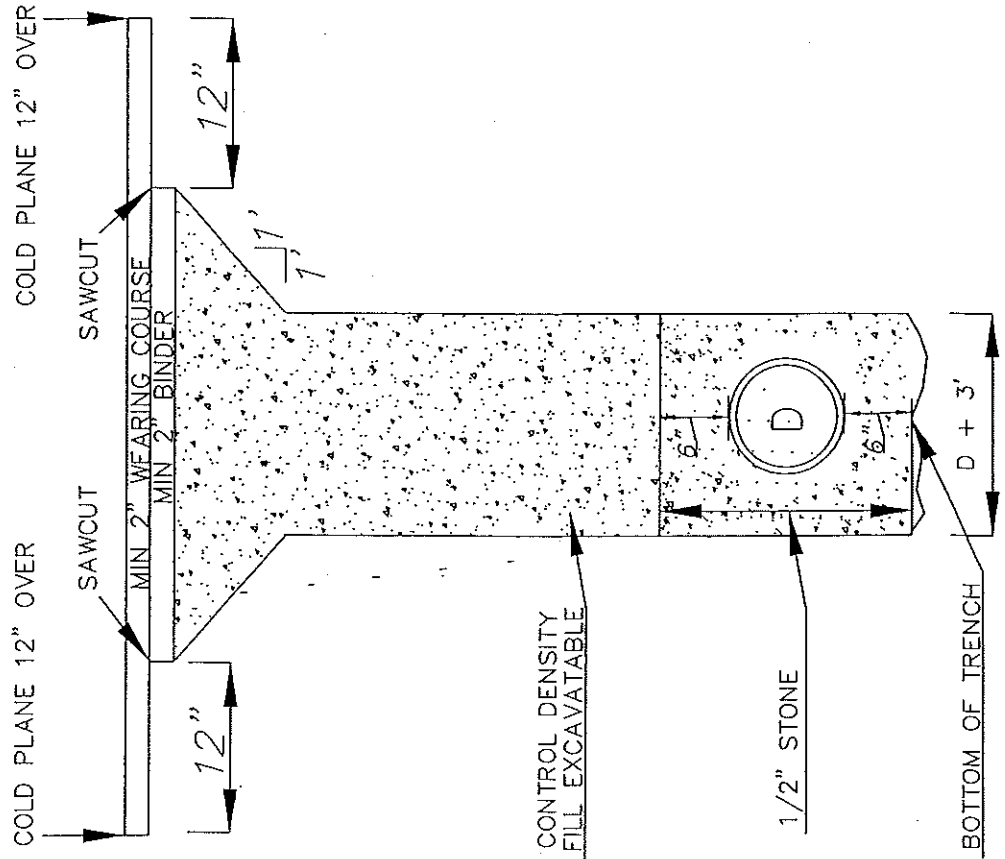
