NATIONAL GRID requests permission to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way:

Wentworth Ave. - National Grid to install (1) SO pole on Wentworth ^{Ave} St. beginning at a point approximately 171 feet south of the centerline of the intersection of Rogers St. National Grid to install new pole 44-1 to service as a service pole for a new gas regulator on Wentworth Ave.

Location approximately as shown on plan attached.

Wherefore it prays that after due notice and hearing as provided by law, it be granted a location for and permission to erect and maintain poles and wires, together with such sustaining and protecting fixtures as it may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked – Wentworth Ave. - Lowell, Massachusetts.
