LOWELL POLICE SEIZED LARGE AMOUNT OF DRUGS AND 3 ILLEGAL FIREARMS DURING TWO SEARCH WARRANT EXECUTIONS IN ONE WEEK

Detectives from the Lowell Police Department executed two search warrants in the city that yielded numerous arrests on drug and firearm charges.

The first warrant was served at 79 Pratt Ave. on July 21st. The search yielded 3 arrests along with 474 suspected Ecstasy Pills, 21 grams of suspected cocaine, 388 grams of suspected 'Molly,' 40 Suboxone Strips, Loaded Ruger .380 caliber pistol, Loaded Sig Sauer 9mm pistol with High Capacity magazine, Marijuana packaged for sale along with materials, scales and records used in the illegal distribution of narcotics. Arrested were:

Sary Rath age 30 of 79 Pratt Ave. He is charged with Trafficking Cocaine over 18 grams, Possession with Intent to Distribute a Class B Substance-Molly/Powder, Possession with Intent to Distribute a Class B Substance-Molly/Crystal, Unlawful Possession of a Firearm during the commission of a Felony, Unlawful Possession of a Firearm While Loaded, Unlawful Possession of Ammunition and Improper Storage of a Firearm.

Samnang Son age 26 of 79 Pratt Ave. He is charged with Possession with Intent to Distribute a Class B Substance-MDMA/Ecstasy, Possession with Intent to Distribute a Class B Substance-Molly/Powder, Possession with Intent to Distribute a Class B Substance-Suboxone, Unlawful Possession of Ammunition, Unlawful Possession of a Large Capacity Feeding Device and Unlawful Possession of a Dangerous Weapon-Brass Knuckles.

Kim Ly Rath age 34 of 79 Pratt Ave. He is charged with Unlawful Possession of a Firearm, Unlawful Possession of a Firearm While Loaded, Unlawful Possession of a Large Capacity Feeding Device, Unlawful Possession of Ammunition and Improper Storage of a Firearm.

The second warrant was executed on at 57 Marshall St. 3rd floor on July 28th. The search yielded a loaded Glock 9mm pistol containing 14 rounds of ammunition (Subsequently Confirmed stolen from Greely Colorado), 3-High Capacity Glock magazines, 61 grams of Suspected Cocaine and \$3672.00 cash. Arrested was:

Sothea An, age 24 of 57 Marshall St. 3rd floor. He is charged with Trafficking Cocaine over 36 grams, Receiving Stolen Property over \$250, Unlawful Possession of a Firearm, Unlawful Possession of a Large Capacity Feeding Device-3 counts, Unlawful Possession of a Firearm During the Commission of a Felony, Unlawful Possession of a Firearm While Loaded and Improper Storage of a Firearm.
