City Clerk Michael Geary:

On behalf of the Markley Group LLC (Markley), Vanasse Hangen Brustlin, Inc. (VHB) is submitting this application for a fuel storage license amendment for review and approval by the Lowell City Council. Markley is working on their next phase of construction at their Internet Data Center located at One Markley Way (2 Prince Avenue) in the former Prince Macaroni factory and warehouse. As part of this phase of construction they are proposing to install additional emergency generators, each with an aboveground diesel fuel belly tank. The diesel fuel belly tanks will hold between 6,000-gallons and 6,350-gallons each of diesel fuel. The total volume of diesel fuel proposed to be stored as part of this phase of construction is 96,700 gallons. This will increase the on-site diesel fuel storage from 71,100 gallons to 167,800 gallons.

In accordance with State Fire Code and the National Fire Protection Association (NFPA) Code 30 for Flammable and Combustible Liquids, the tanks are located greater than fifteen (15) feet from the property line and greater than five (5) feet from any important building on the property. The storage of greater than 10,000 gallons of combustibles in Massachusetts requires a license from the City Council, a permit to store combustibles from the Fire Department and the fuel storage must also be registered with the City Clerk. 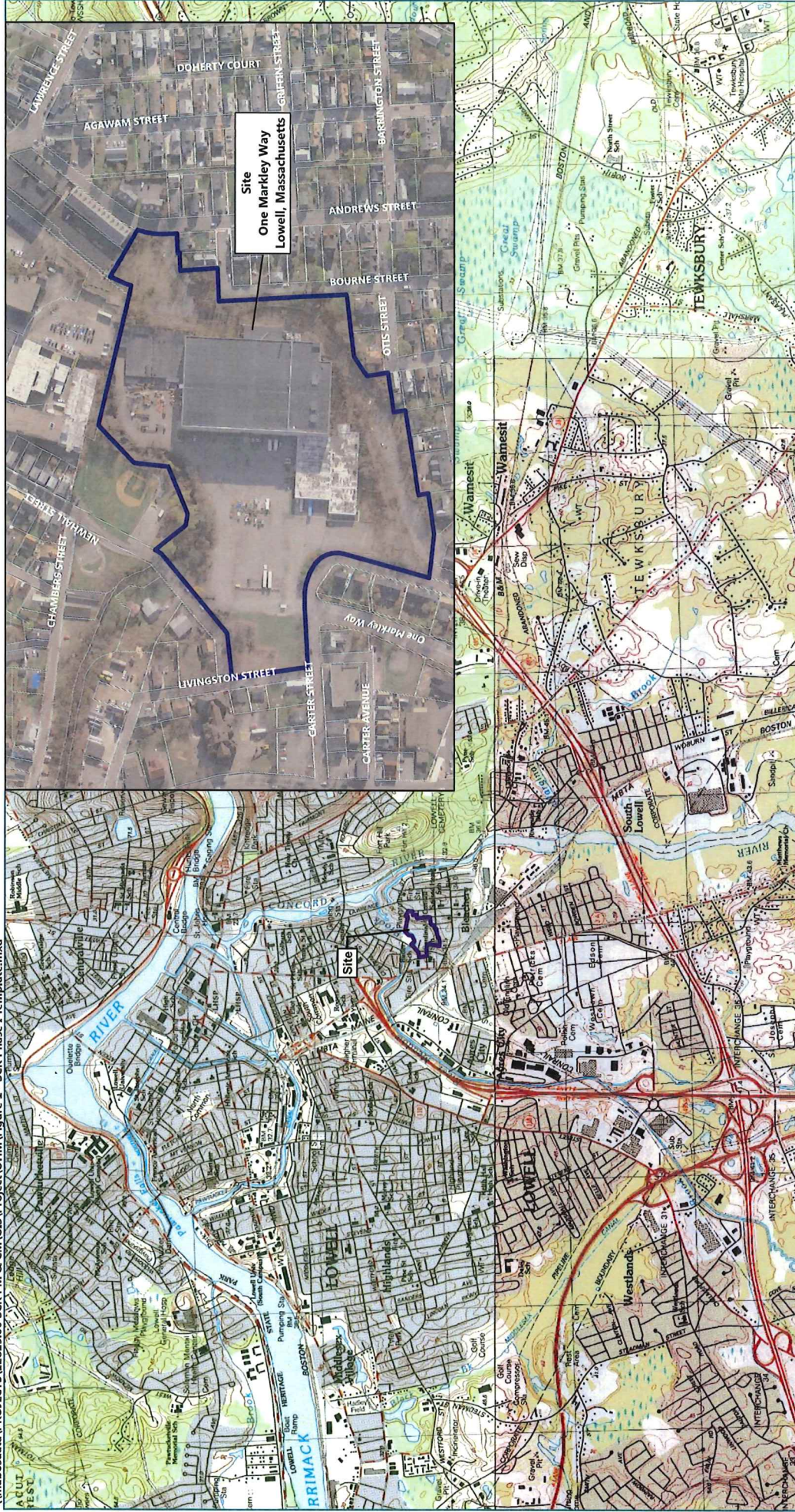

Figure 1 - Site Location and Local Area Map



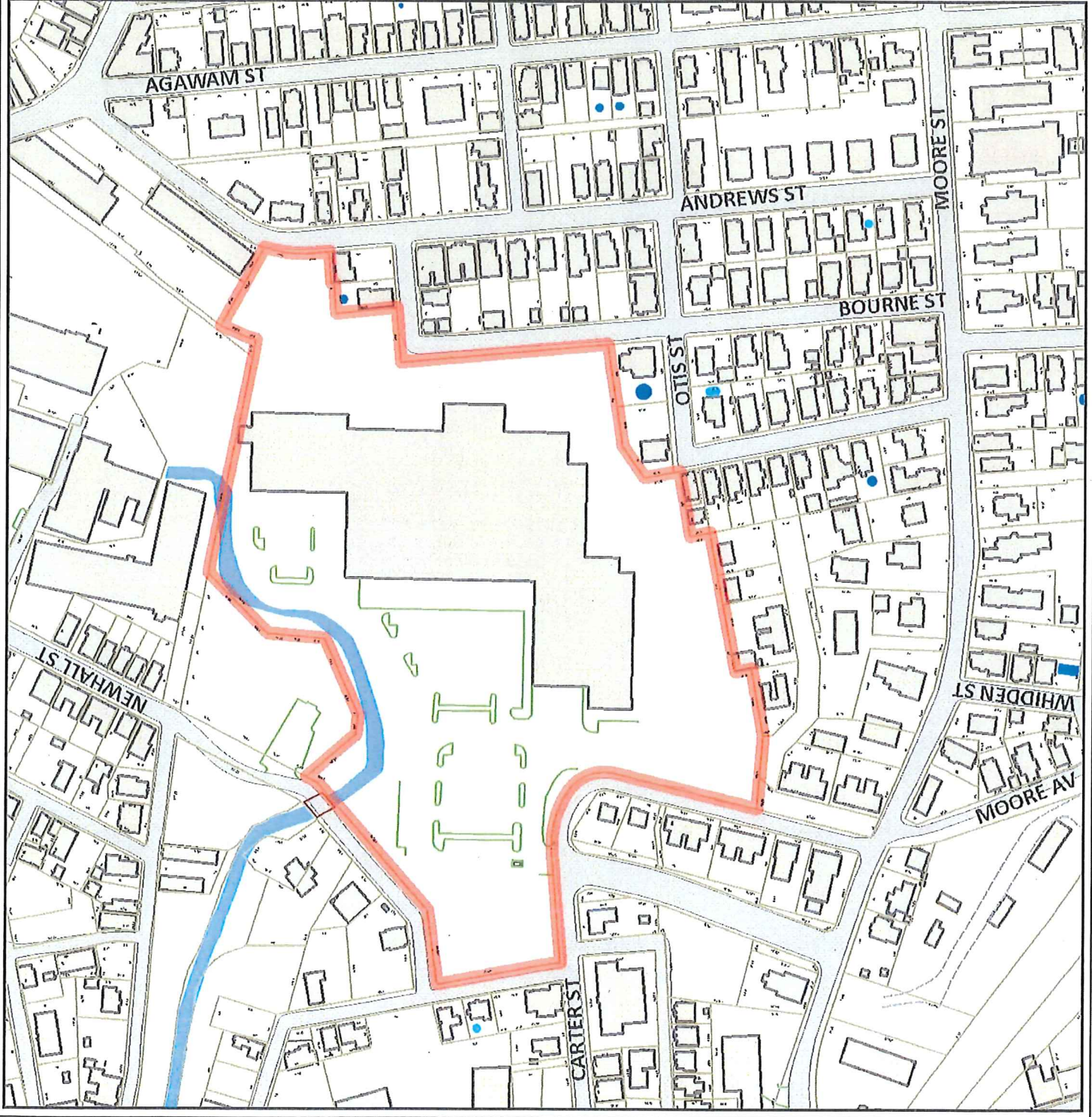

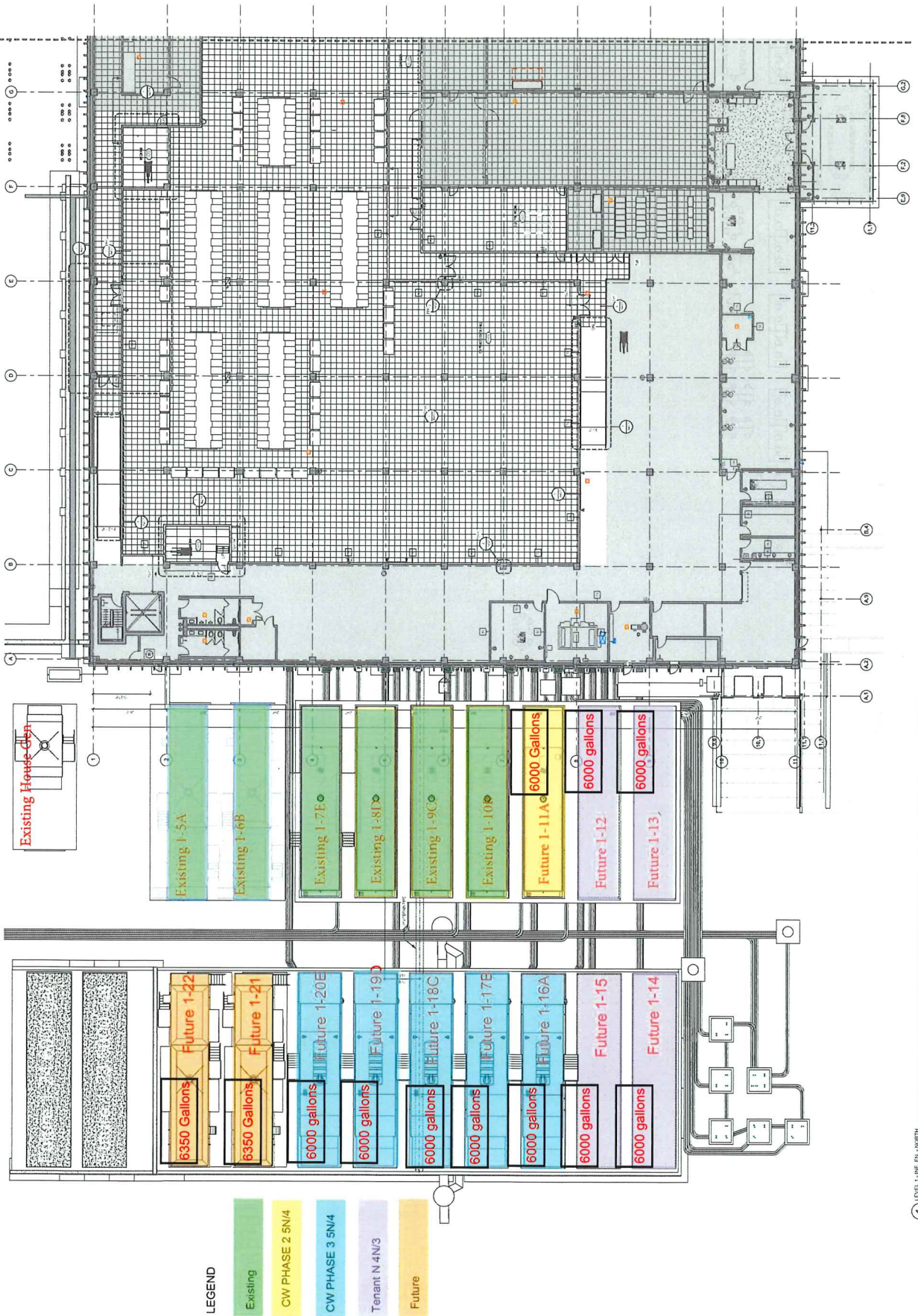
