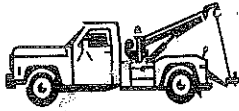
Dear Honorable City Council,

I Simon Kaniu a resident of 95 Andrews St, Lowell, MA had my vehicle towed on 6/19/2018 near my house by Lowell police, registration number: 6HX656. I had parked there the previous night at 11:30 p.m. and when I got out of my house the next day in the afternoon my car wasn't there. I immediately dialed 911 and they transferred me to the non-emergency line to find out why my car was towed and the location of it. I spoke to an officer and he stated the reason as to why my car was towed was because they were working on the street where I had parked. I tried to explain to the officer that when I had parked in that space there were no signs or cones that indicated that they were working on the street as I usually park there quite often. The officer told me that my car was towed to Stuart's Automotive in Lowell and that I had to deal with them.
