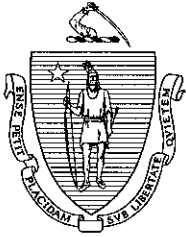

Please see the attached letter which describes the current status of the Solomon Mental Health Center within the City. Bournemouth Health Systems has been licensed by the Commonwealth's Executive Office of HHS Department of Mental Health to operate at the center. Bournemouth Health Systems will be providing:

- 15 bed adult inpatient psychiatric unit
- 15 bed inpatient psychiatric unit for persons with co-occurring substance use and mental health disorders
- 12 bed adolescent unit
- Adult partial hospital program
- Adolescent partial hospital program
- Intensive Outpatient program


