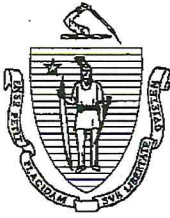

On October 4, 2018, the Bureau of Relocation (the Bureau) received additional information from Peter W. Sleeper Associates, the City of Lowell's Relocation Advisory Agency (RAA), on the Relocation Plan for the new Lowell High School project as requested in the Bureau's letter dated September 10, 2018. The City of Lowell is acquiring a medical office building at 75 Arcand Drive which will result in the permanent displacement of the occupants of more than five business units. The additional information also includes responses to the comments on the Relocation Plan in a letter dated September 6, 2018 from Steven Mollica, Relocation Strategies, on behalf of six (6) tenants in the building.

Pursuant to M.G.L. Ch. 79A and 760 CMR 27.00, the Bureau approves the Relocation Plan for the new Lowell High School project.
