Approving the exemption of Peter Finnegan from the provisions of Massachusetts General Laws Chapter 268A, section 20.

Peter Finnegan is employed as a Board Member on the Board of Parks with City of Lowell; and

Peter Finnegan desires to accept a position with the City of Lowell School Department coaching Lowell High School JV boys' lacrosse; and

In order to be employed in a second position with the City of Lowell an exemption from the provisions of section 20 of Chapter 268A is required; and

In order to qualify for such exemption an employee must satisfy all of the conditions under said Chapter 268A, section 20; and

The position of a coach for Lowell High School JV boys' lacrosse with the Lowell School Department is with a completely independent department; and

The position with the Lowell School Department was publicly advertised; and

Peter Finnegan filed a statement disclosing the second job with the City Clerk; and

The second job will be performed outside the normal working hours of the first position; and

The services to be performed in the Lowell School Department as a coach for Lowell High School JV boys' lacrosse are not part of Peter Finnegan's duties in his primary job as a Board Member on the Board of Parks with the City of Lowell; and

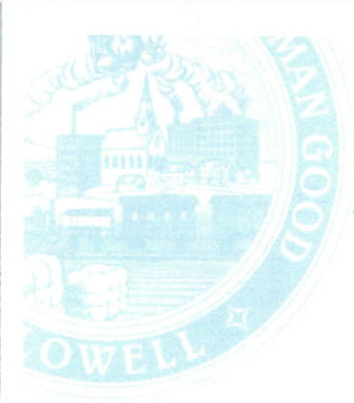
Peter Finnegan will not be compensated in the second position for more than five hundred (500) hours per year; and

The Assistant Superintendent has certified that no employee of that department is available to perform the duties of the second job of coaching the Lowell High School JV boys' lacrosse team for the Lowell School Department.

BE IT VOTED BY THE CITY COUNCIL OF THE CITY OF LOWELL, as follows:

That the City Council of the City of Lowell hereby approves the exemption of Peter Finnegan from the provisions of Massachusetts General Laws Chapter 268A, section 20.
