For the request to replace our existing gas main in the public right of way on Douglas Rd. from 474 Douglas Rd. to 556 Douglas Rd.

TO: Lowell City Clerks Office.

The petitioner respectfully representing the gas distribution business of NATIONAL GRID at 775 Dutton Street, Lowell, Massachusetts, desires to replace its existing gas main with new plastic pipe to service existing customers along Douglas Road. Due to existing conditions, the petitioner is unable to replace the pipe within the 2' ordinance without causing an encroachment on City's new future drain installation location. New location request would place the replacement gas line six feet off the existing curb line on the even numbered side houses on Douglas Rd.

Wherefore it prays that after due notice and hearing as provided by law, it be granted permission to excavate the public right of way to run and maintain a replacement gas line, together with such sustaining and protecting fixtures as it may find necessary for the safe running operation of our underground gas structure, said gas main to be located substantially in accordance with the plan filed herewith marked –“National Grid Gas Main on Douglas Rd. Lowell, Ma.”
